PROGRAMME OVERVIEW

Our GCP Workshop is designed to strengthen the understanding and implementation of ethical principles in clinical research. The one-day workshop brings together esteemed professionals from various institutional ethics committees, regulatory bodies, and academia to provide structured training in ethics and Good Clinical Practice (GCP).

IMPORTANCE OF TRAINING

This training is crucial for all stakeholders to understand and uphold ethical standards, safeguarding the rights and welfare of research participants. It improves the overall quality, integrity, and credibility of research outcomes. This workshop enhances institutional capacity-building by empowering committee members and researchers to perform their roles effectively and with confidence.

According to the NDCT Rules 2019 and the ICMR National Ethical Guidelines for Biomedical and Health Research involving Human Participants (2017), all investigators must undergo Good Clinical Practice (GCP) training and obtain certification before initiating clinical research. Furthermore, the National Medical Commission (NMC) requires postgraduate students to get mandatory training in GCP. Following national regulations, a valid GCP certificate must accompany every research protocol submitted for Ethics Committee approval.

- Participants will be assessed through a post-test.A certificate of merit will be awarded to the best performer.
- Certificates will be issued only upon successful completion of the post-test. Sessions will commence promptly at the scheduled time; late entries will not be permitted.
